NORTH CAROLINA CENTRAL UNIVERSITY APPROVED 2014 HOLIDAY SCHEDULE

* SCHEDULE REMINDERS

All leave earning employees must use leave during the winter break (December 29, 30 and 31, 2013). Compensatory time must be used first. If no compensatory time is available, then the employee must use vacation or bonus leave to cover the absence. In some situations, operational needs may require employees to work during the winter break period. SPA temporary employees will be paid for time worked. STATE HOLIDAYS / NCCU "WINTER BREAK" / ALTERNATIVE OPTIONS

Per the Office of State Human Resources' (OSHR) policy on Holidays and Holiday Pay, permanent SPA employees must either be scheduled off on the specified holiday and receive paid holiday or, if required to work on the holiday, receive holiday premium pay and equal time off. EPA non-faculty employees are entitled to the same paid holidays as provided to employees subject to the State Personnel Act (SPA).

The December 2014 holiday and "winter break" is centered around five (5) scheduled <u>State holidays</u> as follows:

- **⊃** December 23, 2014 (Tuesday) Veterans Day Holiday Observance
- **December 24, 2014 (Wednesday)**Christmas Holiday
- **⊃** December 25, 2014 (Thursday) Christmas Holiday
- **December 26, 2014 (Friday)**Christmas Holiday
- **⊃** January 1, 2015 (Thursday) New Year's Holiday 2015

Additionally, NCCU will observe an extended "winter break" per the following schedule:

- December 29, 2014 Monday (Mandatory Leave Use Required)
- December 30, 2014 Tuesday (Mandatory Leave Use Required)
- December 31, 2014 Wednesday (Mandatory Leave Use Required)

Employees will be required to use leave for the dates of December 29th, 30th, and 31st per the following designated priority: 1) compensatory time; 2) vacation; then 3) bonus leave unless university operations requires an employee to work.

NORTH CAROLINA CENTRAL UNIVERSITY WILL RE-OPEN AND RESUME NORMAL OPERATIONS ON FRIDAY, JANUARY 2, 2015.

Alternative accommodation options may be discussed with Sandra Bailey, Leave Specialist at sbaile20@nccu.edu or (919) 530-6108 for employees who fall short of the necessary vacation and/or compensatory leave time that is required for the winter break.
