BOARD OF TRUSTEES MEETING MINUTES**

**SEPTEMBER 26, 2017**

The NCCU Board of Trustees convened in the W.G. Pearson Dining Hall, Banquet Hall, First Floor on the campus of North Carolina Central University on September 26, 2017. Chairman Hamilton called the meeting to order at 8:30 a.m.

It was moved by Trustee Barbee and properly seconded by Trustee Johnson to approve the nominations of Trustees Walker and Wilkerson to serve as members on the Executive/Personnel Committee. The motion carried.
