APPROVAL OF ACTION ITEM 1: Revisions to Pol – 40.08.1 – On Campus

Residency Requirement Policy: Proposed revisions to the policy include:

<u>Section 2 Scope:</u> Removed wording stating the policy refers to all undergraduate students classified as "Freshman" or "Sophomores".

<u>Section 3 Definitions:</u> Removed definitions for "Freshman" and "Sophomores". Updated the definition for "New First-Time Freshman".

<u>Section 4.1 On-Campus Residency Requirement:</u> Added language requiring all undergraduate students that enter the University as a New First Time Freshman have a two-year (four semester – Fall and Spring Semesters) requirement to live in a University-operated residence hall.

It was moved by Trustee Cameron Emery and properly seconded by Trustee Roderick Allison that ACTION ITEM 1: Revisions to Pol – 40.08.1 – On Campus Residency Requirement Policy, be moved to the consent agenda during open session on Day 2 of the Board of Trustee meeting.

APPROVAL OF ACTION ITEM 2: Revisions to Pol – 40.13.2 – Policy on

Alcoholic Beverages: Propose revisions to the policy include:

<u>Section 6.1.4:</u> Modified the number of days from 7 days to 21 days. Additionally, added language requiring the VC for Student Affairs, or the VC for Student Affairs designee to ensure copy of the Alcohol Beverage Permit and Statement of Responsibility is shared with University Police.

Section 6.1.8: Added language requiring the sponsor, and/or advisor to put safeguards in place for compliance with federal, state, and city ordinances and laws and all University policies during events at which alcohol is served.

Added the following: Section 6.14 & Section 6.15

Section 11: Modified the initial paragraph before Section 11.1.
