## NORTH CAROLINA CENTRAL UNIVERSITY DURHAM, NORTH CAROLINA MINUTES OF A SPECIAL CALL MEETING OF THE BOARD OF TRUSTEES March 16, 2011

The NCCU Board of Trustees held a special call meeting and met via telephone conference call and a public forum was provided in the Chancellor's Conference Room in the Hoey Administration Building. Chairman Adams called the meeting to order at 4:00 p.m. He recognized Ms. Anita Parker to call the roll.

**ADOPTION OF THE AGENDA:** It was moved by Trustee Baron and properly seconded by Trustee Thomas that the agenda be adopted. The motion carried.

It was moved by Trustee Perry and properly seconded by Trustee Ruffin that the Board of Trustees recommend approval of the candidate for the position of Director/Chair, Nursing Department and Professor of Nursing with tenure and directs the staff to forward all relevant information to the UNC Board of Governors for final action. The motion carried.

This form can be completed online at <a href="https://www.ethicscommission.nc.gov">www.ethicscommission.nc.gov</a>. Upon completion it should be forwarded to Attorney Melissa Holloway. Notarization is no longer required, faxes and e-mails are unacceptable. It is mandatory that ALL trustees must file the SEI.

The next NCCU Board of Trustees is scheduled for April 26 - 27, 2011.
